## Associate Director Office of the Chief Information Officer

The appointee will assist the Chief Information Officer (CIO) in overseeing the University-wide Information and Communication Technology (ICT) infrastructure and services as well as information systems and application development. He/she is required to discharge duties including (1) leading EdUHK through the digital transformation journey to become more efficient, innovative, and creative in its administrative, learning and teaching, and research activities through planning, liaising and coordinating with different stakeholders; (2) assisting in the formulation, implementation and review of IT environment, IT-related policies, standards and procedures, IT strategy, IT budget planning and other strategic initiatives in support of the vision and development of EdUHK; (3) coordinating the different teams within the Office of the Chief Information Officer (OCIO) to ensure collaboration and appropriate division of labour in order to achieve synergy and to increase productivity; (4) overseeing the operations of the OCIO, which include user support, network and infrastructure, application development, quality management and generation of results; and (5) assisting in the planning and allocating resources for different operations including support for students, EdUHK and the OCIO, (6) and any other duties as assigned by the CIO.

Applicants should have a recognized degree and relevant professional qualifications; substantial senior management experience in sizable organizations; good knowledge in all aspects of technology such as network, servers, database and application development; strong leadership; excellent interpersonal and communication skills to work with members of University-level committees, government officials and stakeholders of the University; proficiency in both written and spoken English and Chinese (including Putonghua); and preferably with in-depth understanding of IT in Education and diversified IT requirements to support teaching, learning and research in the tertiary education sector.
