Reporting to the Director/Associate Director of Student Affairs, the appointee will lead the Leadership and Service Learning Section in assisting the Director/Associate Director of Student Affairs in developing policies, strategic plans, quality assurance mechanisms and management systems for the provision of student services in the University. He/She will be responsible for overseeing the planning, development and implementation of various areas of student services with specific focus on service learning (local, mainland China and overseas), leadership development, support to student organisations, and student-led activities. He/She is expected to work in close collaboration with internal and external partners in creating learning opportunities and fostering students' whole person development.

Candidates should possess (i) a Bachelor's Degree in a relevant discipline, a higher degree / a professional qualification in areas of specialization is strongly preferred; (ii) substantial relevant post-qualification experience; (iii) proven leadership and strong management skills; and (iv) good mastery of specialist skills and language skills for both English and Chinese. Experience in student affairs / student development service at tertiary level, co-curricular activities management, student liaison and advising will be an advantage.

Salary will be commensurate with qualifications and experience.

The initial appointment will be on a two-year fixed-term contract [applicable to internal and external successful candidates]. Reappointment thereafter will be subject to mutual agreement. Fringe benefits include the University's Voluntary Contributions to MPF Scheme or a contract-end lump sum payment (totaling up to 15% of the basic salary), leave, medical and dental benefits, and, where applicable, housing benefits.
