The Department is now seeking applications for the post of Senior Lecturer II/ Lecturer I/II in the area of a) curriculum and assessment; b) teaching both in and beyond the classroom in diverse educational settings; and c) pedagogy. In addition to course teaching, the appointee will participate in activities related to project supervision, field experience supervision, internship supervision, guidance to students in the capacity of personal tutors, and so on. The appointee is expected to contribute to curriculum and programme development, programme and course management and partake in departmental activities and represent the Department in meetings and various boards and committees, and provide good service contributions to the University and the community.

The appointee should have some relevant teaching experience in the field of curriculum, pedagogical studies, teaching innovation, assessment, and related discipline, as well as demonstrate leadership abilities.

For the post of Senior Lecturer II, applicants should have a Master's degree in a relevant subject discipline plus a minimum of 8 years' relevant post-qualification teaching experience in relevant subject applied for; or preferably a Doctoral degree plus a minimum of 3 years' relevant post-qualification teaching experience in the subject applied for. For the post of Lecturer I, applicants should have a Master's degree in a relevant subject discipline plus a minimum of 4 years' relevant post-qualification teaching experience in the subject applied for. Applicants with less teaching experience may be considered for the post of Lecturer II.

Applicants should preferably possess a relevant professional teaching certificate, e.g. PGDE or qualification of Qualified Teacher Status recognized by the Education Bureau of Hong Kong or other qualification of equivalence, and provide proven evidence of quality teaching and/or successful record of relevant professional experience, at primary/secondary and or tertiary level.

It would be advantageous to applicants to have the ability to teach through more than one medium of instruction (English/ Cantonese/ Putonghua).
