- 3. Withdrawing from the activity at any point in time or failing to depart, any of the payment made will NOT be refunded.
- 4. You are required to submit and complete the application of the Global Learning Enhancement Fund (GLEF) for the activity, and observe the <u>GLEF User Guide for Students</u>.
- 5. Deposit will be refunded, upon your successful completion of the activity, within two months after the activity end date.

- 8. The breach of the abovementioned terms and condition can lead to activity hours not recorded on the Experiential Learning and Achievements Transcript (ELAT), deposit being withheld, and/or immediate termination of my participation in the activity.
